

**NARRATIVE** The undersigned certifies and swears that there is probable cause to believe the above-named defendant, on the 24 day of November, 2021, at approximately 1000  a.m.  p.m. at 22 S B STREET ORMOND BEACH within Volusia County, violated the law and did then and there:

1 The Defendant, Jeremy Todd Imbler, W/M, 09/05/1985, willfully and maliciously injured and damaged by any means and real or personal property  
 2 (City of Ormond Beach owned signs, traffic light poles, crosswalk poles) belonging to another (City of Ormond Beach), including, but not limited to,  
 3 the placement of graffiti (anti-Semitic stickers and spray-painted symbols) thereon or other acts of vandalism thereto. The damage caused an  
 4 interruption and impairment of the City of Ormond Beach Public Service which cost \$2150.00 in labor, replacement of damaged items, and supplies  
 5 to restore.  
 6  
 7 From the dates of November 01, 2021 to December 4, 2021 the Defendant, along with the Co-Defendant (Daniel Howard McGinnis, W/M,  
 8 10/25/1987) placed numerous anti-Semitic stickers on various street signs, traffic light poles, crosswalk poles, traffic control boxes, and other  
 9 miscellaneous items in several locations throughout the City of Ormond Beach. The Defendant also vandalized street signs by marking them with  
 10 symbols of the swastika, "WW3 NOW," "TBS," and a 'fork' style graphic, which were applied via aerosol paint.

12 Located at the intersection of Main Trail and North Nova Road is a Jewish church, B'nai Torah, 403 North Nova Road. Located at 579 North Nova  
 13 Road, is a second Jewish church, Temple Bethel. By placing anti-Semitic stickers at North Nova Road and Main Trail, the Defendant intended for  
 14 these stickers to be viewed by the Jewish community.

**Reported Events**

15  
 16  
 17 On November 1, 2021, Sergeant Dovine, Officer Myers and I responded to Nova Community Park, 440 North Nova Road, Ormond Beach, in  
 18 reference to anti-Semitic stickers that were attached to poles, signs, and a rafter of a shelter. These signs varied in verbiage but all had negative  
 19 comments against the Jewish race. All of the stickers advertised a website for [REDACTED]. At the time of the report, no signs were  
 20 collected as it appeared to be an isolated incident and minimal damage to the City of Ormond Beach. This incident was documented by Officer Myers  
 21 under report number 211100010.

22  
 23 Also located on November 1, 2021, were stickers that were similar in color to the ones located in Nova Community park, but all had been partially  
 24 removed by an unknown citizen. These stickers were posted on the traffic light poles at the intersection of Main Trail and N Nova Rd.

25  
 26 On November 24, 2021, which is documented in Officer Brugone's report number 211100376, numerous anti-Semitic stickers and a spray-painted  
 27 stencil of "WW3 NOW" were placed throughout the City of Ormond Beach.

28  
 29 A traffic control box number 287, had a yellow sticker that reads: ANTIFA IS JEWISH MILITIA "Attacks on Antifa Are Attacks on Jews" HAARETZ  
 30 7-6-2020 For more info: [REDACTED] There were also two QRC codes on the stickers.

31  
 32 The anti-Semitic stickers at North Nova Road and Main Trail/ Wilmette Avenue included two yellow diamonds signs, two green traffic light poles, and  
 33 a silver crosswalk pole.

34  
 35 The stickers on the two yellow diamond signs were the same as the one posted on traffic control box 287.  
 36 The stickers on the green traffic light poles two stickers were blue and white with black and white lettering: Israel Did 9-11 For more info visit:

37 [REDACTED] The third sticker was red and white with yellow and white lettering: The ONLY GOOD COMMUNIST IS A DEAD ONE

38 [REDACTED] There were also pictures of USSR symbol and a helicopter.


39 The sticker on the silver crosswalk pole was white containing five pictures of Jewish Rabbis. The lettering read: [REDACTED]

40 [REDACTED] FOR MORE INFORMATION VISIT [REDACTED]

41 A traffic control box (204) at the intersection of South Yonge Street and West Granada Boulevard had two stickers, one being the same yellow  
 42 sticker that was posted on the traffic control box at North Nova Road and Wilmette Avenue, and a green sticker with black lettering reading: ISRAEL  
 43 DID 9-11 For more information visit: [REDACTED]

44 The interchangeable speed limit sign on the City of Ormond Beach's Speed Trailer E-815, had the yellow "ANTIFA IS JEWISH MILITIA" along with  
 45 the black spray-painted WW3 NOW logo. This trailer was parked along the 70 blk of West Granada Boulevard at the time of the incident.

46 Located on the front of the stop sign located at Corbin Avenue and Lewis Street was "WW3 Now" spray painted in black, appearing to have been  
 47 done with a stencil.

48 A street sign on Tomoka Avenue, just west of South Beach Street had a swastika spray-painted in black on the backside of it.

49 The arrow sign for the pedestrian crosswalk sign at 501 North Orchard Street had the above-mentioned sticker of [REDACTED]

50 [REDACTED] affixed to the front side.

51 On November 26, 2021, Officer Sesemann collected a yellow sticker reading, [REDACTED] ?????????? Google [REDACTED]

52 [REDACTED] for more info visit [REDACTED] This sticker was removed by Officer Sesemann from the traffic utility pole at Main Trail and North

53 Nova Road Officer Sesemann submitted this sticker into evidence for processing under case number 211100396.

54 On November 30, 2021, I, along with Evidence Technician Ott, canvassed the area of the Trails Shopping Center in reference to possible

55 anti-Semitic stickers being posted. Evidence Tech Ott located an FPL power box behind 266 North Nova Road that had the following stickers on it:

56 A yellow in color paper sticker with black color print [REDACTED] ??????????????, Google: [REDACTED], For

57 more visit: [REDACTED]

58 A yellow in color sticker, with a white border. The sticker had black in color print that read " ANTIFA IS JEWISH MILITIA", "Attacks on Antifa Are

59 Attacks on Jews", "Haaretz 7-6-2020", (2) QR codes, and "For more info: [REDACTED]"

60 A blue in color sticker with black print "Israel Did 9-11"

61 A white in color sticker containing five pictures of Jewish Rabbis. The lettering read: [REDACTED] ??? FOR

62 MORE INFORMATION VISIT [REDACTED]

63 Evidence Tech Ott collected the evidence, see his supplemental report for further details.

64 On December 2, 2021, Officer Taska recovered a green in color anti-Semitic sticker that was on a stop sign in Ormond Towne Square. The sign was

65 near the Bank of America. The bank employees advised that the sticker had been in place for approximately two months. There was no surveillance

66 footage available. Please refer to case number 211200026 for further details.

67 On December 2, 2021, Officer Morris responded to 312 Timberline Trail in reference to anti-Semitic stickers being posted on a real estate sign.

68 Officer Morris took a picture of the sign which had three anti-Semitic stickers (two partial and one whole). Officer Morris collected an intact sticker that

69 was handed to him from the reporting party, Tirzah Hochreiter, whose daughter had removed it from an unknown stop sign in the Trails subdivision.

70 The sticker was submitted under Officer Morris' report number, 211200035.

71 On December 4, 2021 Officer David LaBrie completed a Vandalism report in reference to anti-Semitic stickers being posted in the City of Ormond

72 Beach. Please refer to report number 211200053 for details.

**Investigation**

74

75 On November 29, 2021, I retrieved three signs from public works that were removed from the area around city hall due to vandalism. The following

76 signs were submitted into OBPD evidence for processing:

77 1. Stop sign with a red and white sticker and yellow and white lettering reading, "THE ONLY GOOD COMMUNIST IS A DEAD ONE." This sticker was

78 affixed to the front of the sign just below the word STOP. This sign was at Tomoka Avenue and South Beach Street.

79 No Parking Sign with a blue, red, and white sticker reading, "NEW JEW WORLD ORDER 2 PARTY JEW PARTY HOLOCAUST HOAX LYING

80 JEWISH MEDIA USURY DEBT SLAVERY "JUDEO CHRISTIANITY" HOLLYWOOD PERVERSION DESTRUCTION OF THE NUCLEAR FAMILY

81 JEWISH CENSORSHIP OF SOCIAL MEDIA ENDLESS WARS (rest of the wording was removed by a city employee). This sign was posted at South

82 Ridgewood and Corbin Avenue.

83 3. Crosswalk arrow sign with a, [REDACTED] ??? sticker affixed to the front of it.

84 Evidence Crime Scene Supervisor Lancaster processed the backside of three anti-Semitic stickers (two recovered on November 24, 2021 and the  
 85 one recovered on November 26, 2021). The stickers were removed from a stop sign (Tomoka Avenue and South Beach Street), the No Parking Sign  
 86 (located on South Ridgewood Avenue and Corbin Avenue under case number 211100376), and the sticker retrieved under 211100396.  
 87  
 88 On December 1, 2021, the Volusia Sheriff's Office Latent Print Unit identified the prints found on a stop sign, the No Parking Sign, (case number  
 89 211100376), and the sticker retrieved under 211100396 as the Co-Defendant's.  
 90 A DHSMV search of vehicles registered to the Co-Defendant revealed a white 2013 Chrysler van bearing FL tag [REDACTED]. An LPR search of the  
 91 Co-Defendant's van revealed several hits in and around the Ormond Beach area.  
 92 On November 23, 2021, an LPR hit of Defendant's van was received at 2148 hrs, showing the vehicle entering the City of Ormond Beach. At 0127  
 93 hrs on November 24, 2021, a white Chrysler van, matching Defendant's vehicle was captured on surveillance camera stopped in front of 501 North  
 94 Orchard Street. While stopped the front passenger exits the van and places the sticker, [REDACTED] "???" to  
 95 the front side of the pedestrian crossing arrow sign. This video was obtained on December 2, 2021, and was later uploaded to AXON under case  
 96 number 211100376.  
 97 On December 3, 2021, I requested Officer Myers to respond to 1102 West Granada Boulevard. in reference to a supplemental report to case number  
 98 211100376 that he created on November 25, 2021. Officer Myers' report advised that the Speedway gas station (1102 West Granada Boulevard)  
 99 may have a video of the subject who posted anti-Semitic stickers on their property. Note \* This incident occurred on 10/23/2021, and several  
 100 anti-Semitic stickers were placed on the fuel pumps and one on the east side of the building.  
 101 Officer Meyers was able to retrieve video footage from Speedway that was recorded on 10/23/2021, which revealed a vehicle matching the  
 102 Co-Defendant's vehicle (white 2013 Chrysler van) and of a subject with similar physical features of the Co-Defendant, who is captured posting an  
 103 anti-Semitic sticker to a metal box on the east side of the building. Currently, staff has not been able to remove the residue from the stickers that were  
 104 left. If the residue is able to be removed, there will be no damage; however, if during the removal process there could be damage to the pumps.  
 105 Speedway staff will notify OBPD once the residue is removed.  
 106 On December 4, 2021, at 0057 hrs was captured via LPR traveling to the area of North Beach Street and West Granada Boulevard. At 0838 hrs  
 107 Officer D. LaBrie responded to the area of North Beach and West Granada Boulevard in reference to Volusia Sheriff Chitwood reporting anti-Semitic  
 108 stickers "plastered" on businesses along the west side of the Granada Bridge. Located on the north side of Granada Blvd. were three anti-Semitic  
 109 stickers (A Do Not Enter Sign at 4 North Beach Street; glass window 9 West Granada Boulevard; a valet sign at 43 West Granada Boulevard). Two  
 110 anti-Semitic stickers were located at Bailey Riverbridge Garden's Park (1 North Beach Street) on signs belonging to the City of Ormond Beach.  
 111 Please refer to Officer D. LaBrie's report number 211200053.  
 112 On December 4, 2021, Kevin Gray, Director of Public Works for the City of Ormond Beach, provided a sworn written statement to Detective Carini. It  
 113 was noted in Mr. Gray's statement that the City of Ormond Beach sustained a total loss of \$2150.00 in damages, labor, and supplies to wit:  
 114 \$1200.00 in labor  
 115 \$700.00 in damaged street signs  
 116 \$250.00 for equipment  
 117 Mr. Gray advised that the City of Ormond Beach will pursue charges.  
 118 On December 4, 2021, a Felony Vandalism arrest warrant was signed by Mary Jolley for the Co-Defendant.  
 119 Detectives conducted surveillance in the area of the Co-Defendant's residence. Around 2200 hrs the Co-Defendant arrived home, traveling in the

120 front passenger seat of his white 2013 Chrysler van bearing FL tag [REDACTED]. The Co-Defendant was taken into custody without incident.

121 I read the Co-Defendant his rights per Miranda, to which he waived his right. During a post Miranda interview the Co-Defendant advised that he did

122 not want to talk because he was going to jail, however, he continued a conversation. During this conversation the Co-Defendant stated that he had

123 stickers in his van, but was unsure how many, but would later state 20-30. He ordered the stickers via [REDACTED]

124 The Co-Defendant did not think his actions were acts of vandalism. The Co-Defendant advised that he did put stickers up, but did not think it was a

125 felony to do so. When asked why he placed the stickers in Ormond Beach, but lives in Flagler, the Co-Defendant stated that he was from Ormond

126 Beach and liked the area of the Trails. The Co-Defendant further stated that he acted alone.

127 FCSO responded and took custody of the Co-Defendant, arresting him for the open warrant.

128 On December 6, 2021, the Co-Defendant agreed to a non-custodial interview, which was conducted near the outside front entrance of the Ormond

129 Beach Police Department. During this interview, the Co-Defendant advised that he captured the acts of criminal mischief of the vandalized property

130 by taking pictures with his cell phone. The Co-Defendant further stated that he used his cell phone to order the anti-Semitic stickers via [REDACTED]

131 The Co-Defendant advised that he did not act alone, but the Defendant was with him during the acts of vandalism. Co-Defendant continued with

132 stating that the Defendant was the subject who used the spray-paint, which was against the advice of the Co-Defendant.

133 On December 9, 2021 a Search Warrant (signed by Judge Raul Zambrano) was obtained for the Co-Defendant's black Apple iPhone, for all contents

134 except for conversations and/or messages.

135

136 On December 9, 2021, the Co-Defendant responded to the Ormond Beach Police Department so he could read the Search Warrant and provide the

137 passcode for his phone. During which a non-custodial interview was conducted. In the interview the Co-Defendant advised that he would

138 communicate (via text messages) with, the Defendant, setting up times to meet up for their vandalism trips. The Co-Defendant also advised that he

139 exchanged pictures of the vandalism, via text, with the Defendant.

140

141 On December 13, 2021, an additional search warrant was obtained for the Co-Defendant's cellphone in reference to conversations and/or messages

142 containing information relating to or in direct action of furthering the crime of Vandalism. This warrant was also signed by Judge Raul Zambrano.

143 During a text message search of the phone under the contact of the Defendant (Jerome, 386-872-2068) several messages were exchanged between

144 the Defendant and Co-Defendant. The numerous conversations from October 20, 2021 to December 4, 2021 consisted of pictures of the vandalized

145 property, locations that they vandalized, setting times and dates to meet up for their "night op," planning attire to wear (to include a Rabbi costume),

146 advice on about leaving their licenses behind, equipment to bring, the defendant going to buy black and red spray paint, and other related items to

147 their crimes.

148 Below is just some of the information that relates the Defendant to the crimes that the Co-Defendant was arrested for on December 4, 2021.

149 A picture that were sent from the Defendant of the FPL power box located behind 226 North Nova with the Defendant advising this was "Behind

150 Publix." This Publix is located in the Trails Shopping Center and 226 North Nova is also in the Trails Shopping Center.

151 A traffic light pole at Nova Road and West Granada Blvd, with anti-Semitic sticker with message from the Defendant stating [REDACTED],

152 Granada still active Bank\*\*

153 Traffic light pole with anti-Semitic sticker with a message from the Defendant stating, "Corner of nova Wilmette Hold for more intel.. .. roger, entrance

154 of temple has been cleared Still scanning area, standby [REDACTED] corner of nova Wilmette (in front of small temple) still active Entering park grid

155 sector" Conversation continues between the Defendant to the Co-Defendant about the stickers posted at the Nova Community Center, 440 North

 165 Tr., Vendetta... Upheld.. TB-1 Jews-0 Corner of Nova Main Tr. (Holy Grail)" Conversation continues between the Defendant and Co-Defendant with  
 166 the Defendant texting: Addtnl Intel 90% success on targets Incoming.. families beginning to show in mass at baseball fields.. park now filling with  
 167 patrons Situation now dangerous for connected agent.. HimmlerActual Going dark Regroups at HQ Standby..  
 168 On November 7, 2021 Defendant sends a picture of stenciled spray painted "TBS" advising that he will be obtaining glow in the dark paint, which is  
 169 only visible at night time.  
 170 On November 10, 2021 Defendant sends a picture of red painted 'fork' to which the Co-Defendant replies " The trails gonna have mossad come." The  
 171 Defendant's reply is, " Lol im not really gonna do much more of thos here That's why I rigged up my hate bike remember"  
 172 On November 19, 2021 Co-Defendant sends a picture to the Defendant of several anti-Semitic stickers (appearing to be newly received ones). The  
 173 Defendant replies, "Good Running Low." And then sends the Co-Defendant two pictures of the same anti-Semitic stickers posted at a gas station.  
 174 On November 29, 2021 Defendant sends the Co-Defendant posts from the "Next Door" app. This post shows a picture of the anti-Semitic sign posted  
 175 at Nova and Main Trail and a conversation about reporting this to the police. In the Defendant and Co-Defendant's conversation about this post the  
 176 Co-Defendant states that they have to be extra careful at "that intersection" to which the Defendant agrees. The Defendant continues with, "Excactly  
 177 bro lol tizrah can smell us Im gonna check the ones I put by her house lol When I get off."  
 178 On December 01, 2021 Defendant sent a picture advising that he got the cross walk again. The picture is of Nova and Main Trail.  
 179 On Saturday December 4, 2021, the Defendant sent a picture to the Co-Defendant of the Ormond Beach Police Department Crime Scene van. This  
 180 van was at Nova and Main Trail to process newly posted anti-Semitic stickers. The Co-Defendant replies to the picture, " Dectivice looking at  
 181 sticker,"hmmmmm, well..do they?" Defendant replies,"&it's a woman. (Evidence Crime Scene Supervisor Lancaster was processing the scene).  
 182 Conversation continues between the two about not answering questions of the police.  
 183 The Co-Defendant sends a picture of a screen shot of an Ormond Beach Observer new article labeled, " Several street signs, traffic posts, and guard  
 184 rails near City Hall were vandalized with anti-Semitic symbols and stickers." This article was created on November 24th in response to the vandalism  
 185 that had occurred on November 24, 2021 as noted in Officer Brugone's report 211100376. The Defendant responds with, " we hard Baseeed Bro we  
 186 world wide now F [redacted] man Im exciteed as s [redacted] but [redacted] A lettke scared We [redacted] memed our way onto the adl"

 195 On December 13, 2021 Detective Sergeant Voegtle showed a still shot from this video of the Defendant to Dallas Baker, who is the Loss Prevention  
 196 Officer at Walmart (1521 West Granada Boulevard) which is the Defendant's place of employment. Mr. Baker identified the Defendant was the  
 197 subject in the video. Mr. Baker completed a sworn statement.  
 198  
 199 On December 14, 2021, Officer Austin Long conducted a traffic stop on the Defendant for Knowingly Driving on a Suspended Drivers License. Please  
 200 see Officer Long's report number 211200190 for arrest details. While the traffic stop was being conducted I called the Defendant's phone  
 201 (386.872.2068) and Detective Jessica Fowler could see from outside of the truck (2000 Chevy Silverado bearing FL tag Y988UC) my city issued cell  
 202 phone number appear on the Defendant's phone. After placing the Defendant under arrest, he was asked what property he needed from the truck.

 208 as a personal meaning to the Defendant. The Defendant advised that he has not intentions on carrying out violence on Jewish people, or at their

 211 I have considered the circumstances and have determined probable cause exists to charge Jeremy Ibmler in connection with listed Felony Criminal  
 212 Mischief charge.
